October 10	Initial email to High School gifted school level advisors (SLAs) ---READ VDOE documents; info must be made available to all 10th-11th grade students
Nov. 11	Deadline for VPA applicants to inform SLAs of intent to apply for adjudication
Nov. 18	Deadline for VPA Candidates List to be sent to DAAE via email or fax Please specify all vocal categories and any special requests for percussion instruments; verify eligibility per VDOE documents
Nov. 30	VDOE deadline for DAAE office to register (online) applicants for VPA programs for adjudication
December	DAAE will receive individual adjudication schedules to be sent to students
Dec. 9	Deadline for VPA student to submit VPA application pages 1-4 to SLA; SLA will check for accuracy, completeness, and signatures
Dec. 10	Deadline for academic and mentorship applicants to notify SLA of their intent to apply
Dec. 15	Deadline for SLA to notify DAAE of need for ability testing, if scores not available for a student (see VDOE admin docs for acceptable tests – one must be administered within past 3 years)
Weeks of 12/19, 1/3	Gifted resource teachers will conduct ability testing as needed for academic applicants
Dec. 20	SLAs verify that VPA applicants will attend adjudication (\$25 no-show fee must be paid by student)
Jan. 6	Deadline for academic/mentorship student to submit academic/mentorship application pages 1-4 to SLA; SLA will check for accuracy, completeness, signatures, eligibility
Jan. 6	Deadline for academic teachers (Recommendations A and B) to submit narratives and rating scales to SLA

Jan. 6	Deadline for VPA teachers (Rec. A and B) to submit narratives and rating scales to SLA
Jan. 7	VPA adjudication at Christopher Newport University (no exceptions)
Jan. 9	Deadline to submit "excused absences" to reschedule missed adjudications – see VDOE documents for accepted criteria (severe illness with physician's note; blizzard)
Jan. 27	Deadline for completed and reviewed academic/mentorship application packets to be delivered to DAAE by SLAs
Jan. 31	Adjudication scores distributed to school divisions
Feb. 4	Deadline for completed and reviewed VPA application packets to be delivered to DAAE by SLAs; must include yellow adjudication sheets
Feb. 9	Division Selection Committee to meet (8:30-4:30) at Spratley office.
Feb. 24	Postmark deadline to send ALL selected applications to VDOE Deadline for DAAE to submit division nomination reports online to VDOE Non-selected students notified by DAAE that their applications will not go to VDOE
Feb-April	State selection process at VDOE
April 20	All nominees notified of their status by VDOE DAAE will receive letter by mail of status of all students It is strongly recommended that all students who are nominated by the division agree to participate. Students who make other plans should notify their SLA <u>prior</u> to the division selection process so that they are not depriving another HCS student of the chance to be a part of the FANTASTIC Governor's School programs.
